Until further notice the dues will stay at \$135.00 per month. We can increase the Grounds Maintenance to \$6,900.00 to cover the W.E. Lawn prices. Larry moved that we approve the Budget and Kate 2nds it. It was approved.

Kate had several questions....can she paint her front door red? No one minded, but we did suggest that she write a request to the Association just to follow the rules. She also wanted to know about the open area in the back between her and Gwanda....was it something to where she could possiby plant some vegetables. It was OK'd as long as it blends in with the surrounding

area...in other words not rows of corn. Also we all have uneven cement areas and it was suggested that we speak with Larry and Laura, as they had theirs fixed at little cost, and they are very happy with the result.

No one volunteered to keep the Christmas wreaths and ribbons, although Geneva said she would ask her son-in-law. If not, Pat will keep them in her garage attic for another year.
